



## PLAYER WAIVER

### KINGS OF EUROPE 7on7 LEAGUE

#### Assumption of Risk:

Participant or/and Parent/Guardian:

- (1) understand the nature of the activity,
- (2) the demands of said activity relative to the physical condition and skill level of Participant,
- (3) appreciate the types of injuries and illnesses and risks related to treatment for any physical or medical condition which may occur as a result of said activity in which Participant engages.

Participant or/and Parent/Guardian verify that Participant has medical insurance and Participant or/and Parent/Guardian hereby assert that participation in this league and use of competition facilities and services is voluntary and Participant or/and Parent/Guardian knowingly assume all related risks of that participation.

#### Waiver:

In consideration for the participation of Kings of Europe 7on7 league (hereafter KOE 7on7), Participant or/and Parent/Guardian, hereby waive any claims against and covenant not to sue or bring any action against KOE 7on7, sanctioned event operators, site owners and their affiliated companies, or any of their members, directors, officers, employees, site owners, volunteers, sponsors or agents (the "Released Parties"), for any claim, demand, or lawsuit whatsoever related to KOE 7on7's sanctioned events, including, but not limited to, those that arise from or relate to Participant's own acts, the acts of third persons, the effect of the condition of any property, equipment, or premises, or any acts of KOE 7on7's or sanctioned event operator's own negligence, or the negligence of any Released Parties, or anyone else whose conduct may be attributed to the Released Parties.

Participant or/and Parent/Guardian agree that this waiver, release from liability, and covenant not to sue specifically includes, but is not limited to, any claims for personal injury or illness (including death) as well as damage to, or the loss or theft of, any personal property or claims of invasion of privacy.

Participant or/and Parent/Guardian further agree that this waiver, release from liability, and covenant not to sue has legal effect throughout Participant's participation in or arising from KOE 7on7 sanctioned events, as well as each and every time sanctioned event property or facilities are used by Participant, his guests, relatives, or family members, and agree that it shall be construed as if Participant or/and Parent/Guardian acknowledged and attested to it throughout that time and upon each such use.

#### Covid-19

Participant or/and Parent/Guardian acknowledges the contagious nature of COVID-19 and voluntarily assume the risk of maybe being exposed to or infected by COVID-19 by attending this event and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Kings of Europe 7on7 league may result from the actions, omissions, or negligence of myself and others, including, but not limited to volunteers, program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance at the event. On my behalf I hereby release, covenant not to sue, discharge, and hold harmless Kings of Europe 7on7, its employees, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of Kings of Europe 7on7, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Kings of Europe 7on7 event.



**Publicity Release and Consent:**

Participant or/and Parent/Guardian consent to all recording, photographing and filming of Participant (the "Recordings") at sanctioned events and use of Participant's name and performance data (collectively, "Data") and each agree that KOE 70n7 and sanctioned event operators, their licensees and designees may use these Recordings at any time and in any manner without payment to, or additional consent of, Participant or/and Parent/Guardian.

Participant or/and Parent/Guardian release KOE 70n7, sanctioned event operators, their licensees and designees from all claims related to use of the Recordings and Data for promotion of KOE 70n7 and sanctioned events.

**Severability:**

Participant or/and Parent/Guardian further agree that this waiver is intended to be as broad and inclusive as is permitted by applicable law and that if any portion hereof is held invalid, it is agreed that the remaining portion of the waiver will continue in full legal force and effect.

**Acknowledgment of Understanding:**

Participant or/and Parent/Guardian have read this document and fully understand its terms.

Participant or/and Parent/Guardian understand that Participant to compensation for injury resulting from perceived negligence (KOE 70n7 will always strive to provide a safe experience for players and spectators) as of Released Parties to the extent permitted by the applicable law.

Participant or/and Parent/Guardian acknowledge that they are signing the agreement freely and voluntarily, and intend their signatures to be a complete and unconditional release of all liability to the greatest extent allowed by law.

By signing this waiver as Parent/Guardian, I acknowledge that I am consenting to Participant's participation in an KOE 70n7 sanctioned event and represent to KOE 70n7 that I understand that all risks are expressly assumed by Participant and myself and all related claims are expressly waived in advance.
